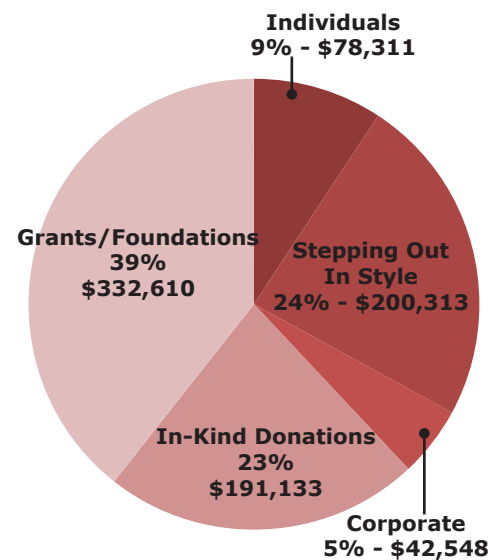

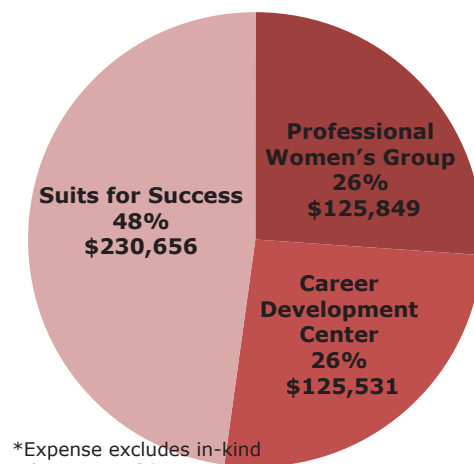

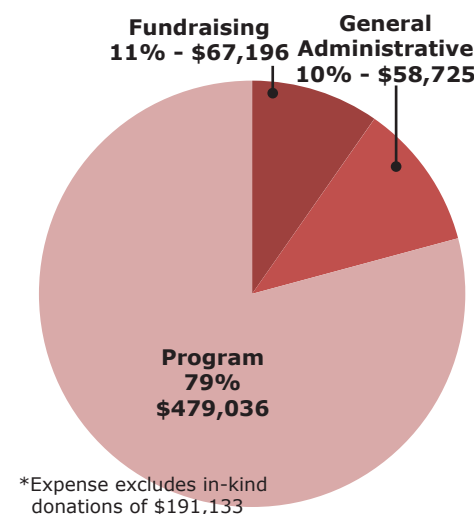


EXPENSE BY PROGRAM
